Report on Race Meeting held at Gawler Racecourse

TRACK: Soft 7 (Rain affected track that will chop out)
Upgraded to a Soft 6 at 1.30 pm retrospective to Race 4
(Moist but not a badly affected track)

RAIL: Out 3 metres 800 metres to 400 metres, true remainder

RACE 1: ROBERT GROCKE / SABOIS DISTANCE MAIDEN PLATE - 2106 Metres

MANILOW (T. Pannell) - rider reported the gelding was inclined to lay in from the vicinity of the 1300 metres until approaching the 600 metres. He added when placed under pressure, the gelding failed to respond to his riding and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

WHYS (S. Fawke) - rider reported that in his opinion, the gelding had not handled today's track condition. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: DAWN SCHULTZ / SABOIS COLTS, GELDINGS & ENTIRES MAIDEN PLATE - 1200 Metres

STYLE GURU (NZ) (C. Jones) - contacted on jumping away.

THE BULL MCCABE (S. Cahill) - shifted in on jumping away contacting STYLE GURU (NZ).

DEEVINE (P. Gatt) - lost its off fore plated during the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

FRANKENSTAR (J. Potter) - approaching the 1100 metres lost its position when it clipped the heels of OURKEED, which shifted out. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: DAWN SCHULTZ / SABOIS COLTS, GELDINGS & ENTIRES MAIDEN PLATE
- 1200 Metres (Cont'd)

LOMAX (J. Holder) - Trainer Mr B. Mueller was advised that a warning had been placed on the gelding in relation to being difficult to load. In the vicinity of the 300 metres stepped in, when placed under pressure, towards **OURKEED**.

MR ROURKE (E. Boyd) - laid in, in the early and middle stages of the event.

OURKEED (S. Fawke) - Trainer Mr D. Magro was advised that a warning had been placed on the gelding in relation to it being fractious in the barriers. Shifted in shortly after the start inside the line of the running rail and in being corrected, shifted out into the running line of **FRANKENSTAR**, which clipped its heels. Rider was reprimanded. In the vicinity of the 300 metres shifted in and away from **LOMAX** and became awkwardly placed on the heels of **BUCKEYE NATION**, which shifted out slightly.

SIPSMITH (J. Toeroek) - jumped away awkwardly and was slow into stride.

RACE 3: ALAN ALSOP / SABOIS FILLIES AND MARES MAIDEN PLATE - 1200 Metres

ARCTIC FLORA (J. Holder) - laid in under pressure in the straight.

DRY VALLEY (A. Jordsjo) - laid out under pressure over the concluding 100 metres. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was fined \$100.

JOMMADOSH (K. Bishop) - slow to begin.

DITZY DANIELLA (L. Annells) - rider reported the gelding laid out throughout the event and failed to let down when placed under pressure.

DUCK DIVE (E. Boyd) - a post-race veterinary examination revealed no visible abnormalities.

LADY BERLINETTA (J. Potter) - raced wide without cover throughout the event.

RACE 4: GEOFF SLADE CLASS ONE HANDICAP - 1706 Metres

The start of this event was delayed approximately two minutes.

ALLAYEZ (J. Opperman) - raced wide without cover throughout the event. In the vicinity of the 300 metres rolled out onto **APPOLLO JET**. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$300.

BLACK SYRAH (D. Tourneur) - shifted in slightly onto **TAPPIN' THOMAS** in the vicinity of the 100 metres.

APPOLLO JET (J. Potter) - in the vicinity of the 300 metres was inconvenienced and obliged to alter course to the inside of **ALLAYEZ**, which shifted out.

TAPPIN' THOMAS (J. Holder) - inclined to lay out under pressure in the straight. In the vicinity of the 100 metres had to momentarily steady when **BLACK SYRAH** shifted in slightly.

WATCH DAT STINGER (P. Gatt) - Stewards permitted P. Gatt to ride the filly 0.5 kg over its declared weight of 54kg. Lost its near fore plate en route to the barrier and required farrier attention. Underwent a pre-race veterinary examination and passed fit to race.

RACE 5: BRETT STONE / SABOIS THREE-YEAR-OLD BENCHMARK 58 HANDICAP - 1100 Metres

FINAL CHANCE (J. Opperman) - a post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mr S. Whittle was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

STATELY STAR (J. Holder) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

MAVETTE (S. Fawke) - shifted in shortly after the start onto TINNY BAR BLUE.

BRIMARVI ROOBOY (J. Toeroek) - laid out rounding the home turn and under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

JIVE BABY (K. Crowther) - rider reported that her saddle had shifted to the off side rounding the home turn placing her at a disadvantage in the straight.

HATEECH (P. Gatt) - laid in under pressure in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

TINNY BAR BLUE (B. Vorster) - inconvenienced shortly after the start when MAVETTE shifted in.

BLUE GRANITE (A. Jordsjo) - hung out rounding the home turn and under pressure in the straight.

RACE 6: GRAHAM PARKER BENCHMARK 54 HANDICAP - 1200 Metres

SILENT GENERAL (T. Pannell) - inconvenienced when contacted by SIR JOHNSON approaching the 400 metres.

SIR JOHNSON (J. Holder) - shifted out approaching the 400 metres in an attempt to improve and in doing so contacted SILENT GENERAL. Rider reported the gelding had not quickened when asked for an effort and had been disappointing over the concluding 100 metres of the event. A post-race veterinary examination revealed no visible abnormalities.

WONAEAMIRRI (S. Fawke) - fractious in the mounting yard and threw itself down on entering the track. Underwent a pre-race veterinary examination who reported the gelding to be lame in the near hind leg. Acting on this advice, Stewards withdrew WONAEAMIRRI at 2.29 pm.

OUTINTHESTREET (J. Opperman) - improved onto and became awkward on the heels of STRYKER FORTUNE at the entrance to the straight and was obliged to alter course to obtain clear ground.

PRINCESS ELLE (A. Jordsjo) - raced keenly in the early and middle stages of the event.

STRYKER FORTUNE (B. Vorster) - raced wide without cover throughout the event. Inconvenienced for a short distance in the vicinity of the 900 metres when tightened between HOLY TORMENT, which rolled in slightly at the same time as SPIRITED MATCH shifted out slightly.

RACE 7: DON KOCH BENCHMARK 54 HANDICAP - 1200 Metres

CARBONE (R. Hurdle) - momentarily inconvenienced shortly after the start when HILUMIERE shifted in.

VICTORY SPOILS (S. Fawke) - slow to begin. Raced fiercely in the early and middle stages of the event.

RACE 7: DON KOCH BENCHMARK 54 HANDICAP - 1200 Metres (Cont'd)

AQUANAUT (J. Potter) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

A ROMAN ROAD (T. Pannell) - raced wide without cover throughout the event.

JAYEFFKAY (E. Boyd) - inclined to shift about under pressure in the straight.

GRAVITY (K. Crowther) - had difficulty obtaining clear ground from the entrance to the straight until inside the 200 metres. Rider explained that at the entrance to the straight she had been disappointed when attempting a run to the inside of AQUANAUT, when that gelding rolled in and then when improving to the outside of AQUANAUT, that gelding rolled out resulting in her electing to shift to the outside of OGGALUTION. She added that after obtaining clear ground GRAVITY had finished the event off well.

HILUMIERE (K. Bishop) - Trainer Mr G. Lesnikowski advised Stewards prior to the event in a change of tactics that being that he would advise the rider to be more positive in the early stages in an attempt to take up a more forward position. Settled mid-field. Shifted in shortly after the start onto CARBONE.

KEPTA (D. Tootell) - slow to begin.

RACE 8: CONGRATULATIONS AND THANK YOU JIM WATTERS RATING 0-62 HANDICAP - 1100 Metres

STRYKE IN STYLE (J. Toereok) - inconvenienced on jumping away.

ROHLON DRUNK (J. Opperman) - shifted in on jumping away onto STRYKE IN STYLE.

LEORBIT (S. Cahill) - a post-race veterinary examination revealed no visible abnormalities.

HOT SIZZLE (T. Pannell) - laid in under pressure in the straight.

ANAMNESIS (K. Crowther) - laid in under pressure in the straight.

WONDER IF (NZ) (P. Gatt) - Stewards permitted P. Gatt to ride the filly 0.5 kg over its declared weight of 54kg. Slow to begin. Raced keenly in the early and middle stages of the event.

RACE 9: COOPERS THANKS GBJC MEMBERS RATING 0-62 HANDICAP - 1506 Metres

DROP THE ORANGE (R. Hurdle) - laid out under pressure in the straight.

WITCHACHAR STAR (T. Pannell) - in the vicinity of the 250 metres had to take hold when FANTASTIC MAGIC shifted out. Rider reported the gelding travelled well in the early and middle stages however, when placed under pressure in the vicinity of the 500 metres, had not responded to his riding and had been disappointing to the finish. He added that in his opinion, WITCHACHAR STAR had not handled the tempo of today's race. A post-race veterinary examination revealed no visible abnormalities.

LOOSE LIP LLOYD (D. Tourneur) - raced fiercely in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

MAORI MAGIC (NZ) (C. Lions) - slow into stride. Raced wide without cover throughout the event.

MIHANY (J. Maund) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 9: COOPERS THANKS GBJC MEMBERS RATING 0-62 HANDICAP - 1506 Metres (Cont'd)

LITTLEBITFUNNY (P. Gatt) - Stewards permitted P. Gatt to ride the filly 0.5 kg over its declared weight of 54kg.

FANTASTIC MAGIC (B. Vorster) - shifted out to improve in the vicinity of the 250 metres onto WITCHACHAR STAR, which was forced to take hold. Rider severely reprimanded and advised to in future to ensure he was sufficiently clear prior to shifting ground.
