**RACE 1: AUSTIN CONDON MEMORIAL / SABOIS TWO-YEAR-OLD CLASS ONE HANDICAP**  
- 1000 Metres

**COOL MAGNUM** (S. Fawke) - raced keenly in the early and middle stages of the event. Raced wide without cover throughout the event. Raced greenly throughout the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**MORPHETT ROAD** (P. Gatt) - slow to begin.

**KIRINIA** (J. Opperman) - jumped away awkwardly. Raced wide without cover throughout the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$100.

**JOURNEY TO RIO** (A. Jordsjo) - slow into stride. Laid in under pressure in the straight.

**STRIP CLUB** (E. Annells) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

**RACE 2: ROYAL EXCHANGE HOTEL, KADINA / SABOIS TWO-YEAR-OLD & OVER MAIDEN**  
PLATE - 1000 Metres

**EIGHT OVER EIGHT** (S. Fawke) - raced keenly in the early and middle stages of the event.

**PINDARIC** (E. Boyd) - fractious in its barrier after being loaded and struck its head. Laid in under pressure in the straight. A post-race veterinary examination revealed blood in its right nostril. Stewards were satisfied that the blood was caused by external trauma in accordance with AR79(8). First aid administered.

**ANOTHER WHISPER** (C. Lions) - slow to begin.

**RACE 2: ROYAL EXCHANGE HOTEL, KADINA / SABOIS TWO-YEAR-OLD & OVER MAIDEN PLATE - 1000 Metres (Cont'd)**

**MISS FLATLEY** (E. Annells) - raced wide without cover throughout the event.

**ZIPADEE** (D. Tourneur) - hampered on jumping away. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**FRENCH FIELDS** (B. Vorster) - hampered on jumping away when contacted by MALVADO. Raced keenly in the early stages of the event. Laid in under pressure in the straight.

**MALVADO** (J. Opperman) - shifted out on jumping away and contacted FRENCH FIELDS. Laid out under pressure in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$200.

**RACE 3: HENSON AND CO / SABOIS TWO-YEAR-OLD & OVER MAIDEN PLATE - 1400 Metres**

**GREY FROG** (T. Pannell) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**OUR JOURNEYMAN** (J. Opperman) - jumped away awkwardly. Raced keenly in the early and middle stages of the event.

**FACTOROFHOTRACHAEL** (P. Gatt) - raced keenly in the early and middle stages of the event.

**INVESTITURE** (R. Hurdle) - shifted out at the entrance to the straight onto AMBER HAZE. Laid out under pressure in the straight.

**B'ELANNA TORRES** (D. Caboche) - slow to begin. Laid in under pressure in the straight.

**AMBER HAZE** (T. Voorham) - inconvenienced at the entrance to the straight when taken wider by INVESTITURE.

**RACE 4: TAYLORS WINES BENCHMARK 62 HANDICAP - 1600 Metres**

**MARINA** (S. Fawke) - a post-race veterinary examination revealed no visible abnormalities.

**BACK POCKER** (R. Hurdle) - slow into stride. A post-race veterinary examination revealed no visible abnormalities.

**FANTASTIC MAGIC** (B. Vorster) - raced keenly in the early and middle stages of the event.

**LITTLEBITFUNNY** (M. Collett) - shifted out on jumping away onto WALKABOUTCREEK. Laid in rounding the home turn and under pressure in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

**WALKABOUTCREEK** (K. Crowther) - hampered on jumping away when contacted by LITTLEBITFUNNY. Made excess respiratory noise during the event. A post-race veterinary examination revealed no visible abnormalities.

**RACE 5: SAGLE CONSTRUCTIONS BENCHMARK 62 HANDICAP - 1050 Metres**

**MASTERATI** (M. Collett) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**DOMINATION** (J. Opperman) - laid in under pressure in the straight.

**RACE 5: SAGLE CONSTRUCTIONS BENCHMARK 62 HANDICAP - 1050 Metres (Cont'd)**

**KNOTTED** (D. Caboche) - awkward in its action over the concluding 200 metres. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer Ms K. McKerlie was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**GOODGEE** (A. Jordsjo) - laid in under pressure in the straight.

**DELUXE DESIGN** (K. Crowther) - laid in under pressure in the straight.

**CIBACHROME** - underwent a pre-race veterinary examination on arrival at the barriers which revealed the mare was lame in the near foreleg. Acting on this advice Stewards withdrew CIBACHROME at 2.29 pm.

**RUSHWA** (D. Tourneur) - raced keenly in the early and middle stages of the event.

**RACE 6: ADELAIDE GALVANISING INDUSTRIES BENCHMARK 54 HANDICAP - 1300 Metres**

**NOTHING NEEDED** (M. Collett) - jumped away awkwardly. Raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**REAL EASY** (E. Boyd) - lost its off hind plate during the event.

**STATELY STAR** (J. Holder) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

**AURMAN ZOU** (A. Jordsjo) - in the vicinity of the 400 metres had to alter course to the inside of QUICK BISCUIT, which rolled in.

**VICTORY SPOILS** (S. Fawke) - raced fiercely in the early and middle stages of the event.

**TWICE FORGOTTEN** (D. Caboche) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$300.

**PIERRO'S PROMISE** (D. Tourneur) - inconvenienced in the vicinity of the 300 metres when CHUCKLES rolled out. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$300.

**AUSTIN RAIDER** (K. Zechner) - slow to begin.

**QUICK BISCUIT** (K. Bishop) - raced wide without cover throughout the event. Rolled out slightly onto AURMAN ZOU in the vicinity of the 400 metres.

**CHUCKLES** (B. Vorster) - rolled out slightly in the vicinity of the 300 metres onto PIERRO'S PROMISE.

**RACE 7: MY BUTCHER COLTS GELDINGS & ENTIRES RATING 0-58 HANDICAP - 1200 Metres**

**LI'L HANK** (J. Maund) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**WHEN STARS ALIGN** (T Voorham) - inconvenienced shortly after the start when tightened by MAVETTE. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**MAGIC PHANTOM** (J. Opperman) - hampered shortly after the start when tightened onto AMERICAN XPRESSX.

**RACE 7: MY BUTCHER COLTS GELDINGS & ENTIRES RATING 0-58 HANDICAP**  
**- 1200 Metres (Cont'd)**

**JAGERNAUT** (B. Vorster) - raced keenly in the early and middle stages of the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**MAVETTE** (S. Fawke) - shifted in shortly after the start onto WHEN STARS ALIGN. A post-race veterinary examination revealed no visible abnormalities.

**PIVOTAL FORCE** (J. Toeroek) - shortly after the start shifted out onto MAGIC PHANTOM. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**HAHNDORF** (D. Tourneur) - jumped away awkwardly and was slow to begin. Rider was advised of his obligations in riding his mounts to the finish of the race in accordance with AR131(b).

**KNAVESMIRE** (E. Annells) - raced wide without cover throughout the event. Laid in under pressure in the straight.

**SPIRITED MATCH** (M. Collett) - raced wide without cover throughout the event. Rider was advised of her obligations in riding her mounts to the finish of the race in accordance with AR131(b).

**AMERICAN XPRESSX** (C. Lions) - inconvenienced shortly after the start when tightened between MAGIC PHANTOM and WHEN STARS ALIGN.

**RACE 8: COOPERS BENCHMARK 64 HANDICAP - 1400 Metres**

**SAUCY JACK** (M. Collett) - raced fiercely in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**SPLASH SOME CASH** (A. Jordsjo) - contacted on jumping away.

**WAIKATO EXPRESS** (J. Toeroek) - slow to begin.

**MABEL JOSEPHINE** - acting on confirmed advice from Trainer Ms K. Evans that the mare had swelling in its near fore hoof and would be unfit to race, Stewards withdrew the gelding at 10.02am.

**SONO DOLCE** (J. Opperman) - shifted out abruptly on jumping away contacting SPLASH SOME CASH. Improved onto the heels of SAUCY JACK in the vicinity of the 800 metres and had to be steadied for a number of strides. Lost its off fore plate during the event.
