Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Saturday, 15 August 2020

TRACK: Soft 6 (Moist but not a badly affected track)
Upgraded to a Soft 5 at 1.10 pm retrospective to Race 3
(Track with a reasonable amount of give in it)

RAIL: Out 3 metres 1200 metres to winning post, true remainder, sectional 604 metres

RACE 1 HOLDFAST INSURANCE HANDICAP - 1100 Metres

JABALI RIDGE (J. Eaton) - in the vicinity of the 200 metres raced in restricted room for a short distance when awkwardly placed between THE MULTIPLIER, which laid out at the same time as CELESTINE laid in.

SO YOU CAN (J. Holder) - jumped away awkwardly. Laid in under pressure in the straight.

THE MULTIPLIER (T. Pannell) - jumped away awkwardly. Inclined to lay out under pressure in the straight.

CANDY DUDE (J. Toeroek) - raced keenly in the early and middle stages of the event. Hung out over the concluding 600 metres.

CELESTINE (B. Vorster) - raced keenly in the early and middle stages of the event. Laid in under pressure in the straight.

RACE 2: TAB HANDICAP - 2006 Metres

VON COSTA GLASS (P. Gatt) - in the vicinity of the 1100 metres improved onto the heels of FLOW METER and had to be steadied.

ANDREA MANTEGNA (USA) (T. Pannell) - laid out under pressure in the straight.

CLASSY JOE (J. Maund) - rider pleaded guilty to a charge under AR132(7)(a)(i) in that he used his whip in a forehand manner in consecutive strides prior to the 100 metres and was fined \$200. Rider also pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres, was fined \$1500 and was suspended for four meetings commencing midnight Sunday, 16 August and to concluded at midnight Wednesday, 26 August 2020.

RACE 2: TAB HANDICAP - 2006 Metres (Cont'd)

JUST ROLLING (K. Crowther) - slow to begin.

COBBERS MATE (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

Correct was delayed to allow T. Pannell (ANDREA MANTEGNA (USA)) placed second, to view the vision in the straight. After doing so T. Pannell lodged an objection against CLASSY JOE (J. Maund), being declared the winner alleging that the rider had breached AR132(7)(a)(i) and (ii) in relation to the whip rule. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards *dismissed* the protest.

RACE 3: AAMI HANDICAP - 1100 Metres

SOUL FIRE (C. Jones) - inclined to lay in under pressure in the straight.

VIEIRA (J. Eaton) - a post-race veterinary examination revealed no visible abnormalities.

ATOMIC LOKADE (B. Vorster) - slow to begin.

FORTUNE FOLLOWS (K. Crowther) - shifted out abruptly shortly after the start and lost ground.

RACE 4: WEST ADELAIDE FOOTBALL CLUB HANDICAP - 2500 Metres

EXALTED RUTH (S. Logan) - raced keenly in the early and middle stages of the event.

HASTA LA FIORENTE (B. Vorster) - raced fiercely in the early and middle stages of the event.

RACE 5: SCHWEPPE HANDICAP - 1600 Metres

ANALYTICA (NZ) (T. Pannell) - difficulty obtaining clear ground from inside the 300 metres until inside the 200 metres. In the vicinity of the 200 metres shifted out onto ENKI, which was hampered. Rider reprimanded under AR131(a) and advised to take greater care in future. In the vicinity of the 100 metres was momentarily inconvenienced when BLOW TORCH shifted in abruptly.

TERRITORY TITAN (K. Crowther) - laid in under pressure in the straight.

BLOW TORCH (B. Vorster) - inclined to shift about under pressure in the straight. In the vicinity of the 100 metres shifted in abruptly onto ANALYTICA (NZ).

ENKI (J. Holder) - in the vicinity of the 1400 metres shifted in slightly onto GOING GAGA, which was momentarily inconvenienced. In the vicinity of the 200 metres had to be steadied for a number of strides when ANALYTICA (NZ) shifted out.

SO WE ARE (C. Jones) - jumped away awkwardly and shifted in contacting GOING GAGA. A post-race veterinary examination revealed no visible abnormalities.

GOING GAGA (A. Jordsjo) - contacted on jumping away by SO WE ARE. In the vicinity of the 1400 metres was momentarily inconvenienced when ENKI shifted in.

RACE 6: FLEURIEU MILK COMPANY HANDICAP - 1506 Metres

ROTHMOORE (C. Jones) - a post-race veterinary examination revealed no visible abnormalities.

RACE 6: FLEURIEU MILK COMPANY HANDICAP - 1506 Metres (Cont'd)

MEEHNI (J. Eaton) - laid out under pressure in the straight.

PEARL BANDIT (J. Holder) - laid in, in the straight.

LISETTE (T. Pannell) - bumped with **AUSTIN RAIDER** on jumping away. Approaching the 1300 metres shifted in onto **AUSTIN RAIDER**. Rider severely reprimanded under AR131(a).

CONCONI (R. Hurdle) - laid out under pressure in the straight.

AUSTIN RAIDER (K. Zechner) - bumped with **LISETTE** on jumping away. Raced fiercely in the early and middle stages of the event. Approaching the 1300 metres had to take hold when **LISETTE** shifted in.

DOUBLE POCKETS (E. Boyd) - faulted in the vicinity of the 600 metres and was eased from the event. Dislodged its rider in the vicinity of the 300 metres. A post-race veterinary examination revealed a possible sesamoid fracture to the near foreleg. First aid administered. **DOUBLE POCKETS** was referred to the Morphettville Equine Clinic for further diagnosis. Rider was examined by the First Care Medical Personnel and passed fit to ride. Trainer, Ms S Nolan, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

RACE 7: SPRING STAKES - 1200 Metres

DALASAN (J. Holder) - laid in under pressure in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

BEHEMOTH (T. Pannell) - slow to begin.

MORE THAN EXCEED (NZ) (K. Crowther) - raced keenly in the early and middle stages of the event. In the vicinity of the 600 metres improved onto the heels of **MORVADA** and had to be steadied. Held up from the entrance to the straight until in the vicinity of the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

FOX HALL (B. Vorster) - lost its near fore plate during the event.

CROWN FONTEIN (S. Fawke) - improved onto the heels of **EXTRA TIME** approaching the 100 metres and shifted out inconveniencing **MASTER CHUM**.

MASTER CHUM (E. Boyd) - inconvenienced approaching the finish when **CROWN FONTEIN** shifted out.

RAINMOTH (C. Jones) - inclined to shift about under pressure in the straight.

EXTRA TIME (J. Eaton) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

RACE 8: FURPHY HANDICAP - 1200 Metres

PERFECT COMMAND (C. Jones) - a post-race veterinary examination revealed no visible abnormalities.

SILVERHAWK (S. Logan) - laid out under pressure in the straight. Inside the 100 metres shifted out onto **PIVOTAL FORCE**, which was inconvenienced when taken wider. Rider was advised to make a greater effort to straighten her mounts when they commence to shift in future.

RACE 8: FURPHY HANDICAP - 1200 Metres (Cont'd)

BEEOKAY (T. Pannell) - slow to begin. In the vicinity of the 200 metres was obliged to alter course to obtain clear ground. Lost its near fore pate during the event. Rider advised he had been instructed to settle further forward in this event however, after beginning a touch slow and as a result of the formation of the field, he was unable to obtain a position closer as instructed.

GALAHAD GURU (J. Holder) - rolled out slightly in the vicinity of the 1000 metres onto **JUST CHIPPING AWAY**. Raced in restricted room approaching the finish when tightened onto **BEEOKAY** by **PIVOTAL FORCE**.

JUST CHIPPING AWAY (K. Crowther) - in the vicinity of the 1000 metres had to be steadied when shifting in at the same time as **GALAHAD GURU** rolled out slightly. Raced wide without cover throughout the event.

DYNASTIC (S. Fawke) - held up from the entrance to the straight until the vicinity of the 300 metres.

PIVOTAL FORCE (J. Eaton) - in the vicinity of the 100 metres was inconvenienced when taken wider by **SILVERHAWK**. Approaching the finish was again taken out by **SILVERHAWK** onto **GALAHAD GURU**.

DOUBLE BLUE (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

HAHNDORF (D. Tourneur) - inclined to rear on jumping away and was slow into stride.

RACE 9: M&J CHICKENS HANDICAP - 1100 Metres

PHANTOM DATE (S. Cahill) - shifted in, in the vicinity of the 1000 metres onto **NARRATIVE STAR**, which was hampered. Rider reprimanded under AR131(a).

CHUCKY (C. Jones) - shifted in, in the vicinity of the 200 metres onto **VIVI VALENTINA**, which was forced to momentarily take hold. Rider reprimanded under AR131(a).

VIVI VALENTINA (J. Toeroek) - in the vicinity of the 400 metres had to momentarily take hold when **CHUCKY** shifted in.

NARRATIVE STAR (J. Eaton) - shifted out on jumping away and bumped **ANAMNESIS**. Raced keenly in the early and middle stages of the event. In the vicinity of the 100 metres was hampered when **PHANTOM DATE** shifted in. A post-race veterinary examination revealed no visible abnormalities.

EMINENT SON (K. Zechner) - rolled out slightly in the vicinity of the 900 metres at the same time as **PHANTOM DATE** shifted in, resulting in the gelding becoming awkwardly placed on heels. Raced keenly in the middle stages of the event.

WONDER IF (NZ) (P. Gatt) - held up from the vicinity of the 600 metres until the entrance to the straight.

ANAMNESIS (A. Jordsjo) - contacted on jumping away. Raced keenly in the early and middle stages of the event.

RUSHWA (T. Pannell) - jumped away awkwardly and was slow to begin. A post-race veterinary examination revealed no visible abnormalities.

CIBACHROME (T. Voorham) - held up from the entrance to the straight until approaching the 200 metres.
